











REPORT ON WOMEN EMPOWERMENT PROGRAM IN LIBERIA

ONE DAY POLICY ADVOCACY FORUM FOR THE EMPOWERMENT OF WOMEN



TWO DAYS TRAINING IN LEADERSHIP AND ENTREPRENEURSHIP

1.0 HOW IT STARTED

The African Capacity Building Foundation(ACBF) in partnership with the African Bank for Economic Development (BADEA) sucessfully sponsored a one (1) days forum and two(2) days training activities on Women Empowerment in Liberia. The forum was organized by the Liberia Macroeconomic Policy Analysis Center (LIMPAC) under the theme "Empowering Women in Agriculture and Entrepreneurship with the tehnical support of the Cooperative Development Agency of Liberia.

The planning for the forum actually started in early september 2017 when ACBF through its project officer for West Africa, Mr. Dickson Antwi fielded a Mission to Monrovia. During the first mission, LIMPAC reached out and invited various women entrepreneurs groups and cooperatives for a meeting and discussion with the ACBF mission. More than 75 women groups and cooperatives attended the first meeting and Mr. Antwi explained the objectives of the initiatives.

At the first meeting, LIMPAC and the ACBF also distributed more than one hundred and thirty (130) capacity needs assessment survey questionnaires, and one hundred and six (106) forms were filled and returned by the women. From the returned forms, the following information were collected:

- Most women selected Wholesale and Retail Trade as their type of business activity, followeby by Agriculture and Forestry and Fishing as their area of interest.
- In terms of years of experience in doing business, most of the women on average had eight years (8) of experience as majority selected junior and senior secondary education as their education level.
- Most of the women respondent skill transning in marketing and customer services, follow by financial mangaement and planning and organizing.
- The women expressed that their major challenge was with limited access to reliable source of funding.

A follow up mission headed by Mr. Antwi was made in late july 2018 to finalize all the technical details for the forum and the training package for the women beneficiaries. Separate meetings and enagements were held with women

grouping along with representatives of the Cooperative Development Agency; the agency of government that is responsible for regulating agriculture cooperatives in Liberia.

2.0 THE FORUM & TRAINING PROGRAMS

All the activities, the women advocacy forum and leadership training of women in agriculture lasted for three days, September 19-21 at the Bella Casa Hotel in Sinkor. The Women Advocacy Forum which was convened on the 19th of September was attended by more than 150 women entrepreneur, women farmers, leaders of women farmer cooperatives and networks, government, civil society, and research and academic institution and stakeholders across the fifteen political subdivisions. The forum was offically opened by the Vice President of the Republic of Liberia, Her Excellency, Chief Jewel Howard Taylor. Vice President Taylor, used the occasion to thank LIMPAC and the ACBF Team for organizing the forum and the two days training for the women of Liberia. She underscored the need for Liberians to prioritize agriculture because there are tremendous gains from agriculture financially and Liberia is well placed given its abundant fertile soil that is under-utilized. Vice President Taylor also urged Liberian women to encourage their children to get back to the soil so Liberia can be self-sufficient in food-production like Liberia were between 1960 and 1970. She also used the occasion to re-emphasize the need for the government of Liberia to re-operationalize the Agriculture Cooperative Development Bank (ACDB) to address financing challenges of the farmers, especially women in Agriculture.

For her part, the Deputy Minister for Budget and Development, Honorable Tenneh Brunson, on behalf of Minister Samuel D. Tweah, Jr. thanked the ACBF for the continued support to Liberia capacity building initiatives, recounting the ACBF support in establishing and operationalizing a econometric forecasting and training laboratory within the Ministry of Finance and Development Planning.

Madam Brunson also praised Liberian Business Women as being dynamic and more likely to be self-employed than men. She underscored that the result of the Liberian Civil War posed a serious challenge to the capacity building of women to enhance their skills in entrepreneurship. Deputy Minister Brunson also named other challenges faced by women as: limited financial infrastructure, restricted access to market, insufficient network to support women entrepreneurs, wide gender-gap, high gender segregation, poor access to credit for women, vulnerability to gender-based violence, lack of general representation of women businesses in wide business network like the Liberia Chamber of Commerce, etc. Consequently, Hon. Brunson proffered the following recommendations: a comprehensive and sensitive skill enhancement program for women entrepreneurship should be established, flexible business and skills training program should also be established, there should be mechanism for easy access to finance by women, integrated financial literacy training programs should be prioritized, and policymakers should seize the opportunity to address the obstacle that women face in the business arena through legislation and policy reforms.

On behalf of the ACBF, Mr. Dixon Antwi highlighted the significance of ACBF since its formation in 1991 by African Heads of State. He disclosed that the ACBF has spent about 700 million across the continent on the capacity building since its inception in 1991. Mr. Antwi stated that the essence of the forum and training was to provide opportunities for women and to discuss issues that impact the lives of women in order to evolve effective policies. He acknowledged the role of women and also lauded key actors who made the program to be possible. Mr. Antwi emphasis that the three days event is a pilot initiative in three African Countries, namely: Liberia, Malawi, and Rwanda. At

the conclusion of the three days event, specific policy recommendations for consideration by policymakers towards enhancing the role of women farmers and their network would have been fully addressed in Liberia. Key recommendations include the establishment of Women Cooperative Bank and design and implementation of favorable policies for women agriculture and entrepreneurs.

For his part, the Executive Director of LIMPAC, Mr. Del-Francis Wreh gracefully expressed his appreciation to all participants for their full attendance at the forum. He pointed out, that the forum was mainly organized to articulate and discuss challenges faced by women in Liberia especially for women in agriculture and women entrepreneurs. Mr. Del-Francis Wreh also emphasized that the forum is being marked as an important event in Liberia under the administration of His Excellency Dr. George Manneh Weah in achieving the Pro-Poor Agenda for Prosperity and Development (PAPD) by prioritizing women concerns. He further conveyed that the total number of women cooperative at the forum constitute 150 and by extension acknowledged their effort for accepting the invitation especially under difficult road conditions.

2.1 Two Days Training of Women Cooperatives in Leadership

The second section of the women empowerment program was a two days training in leadership and entrepreneurship for the women in agriculture and it ran from September 20 -21 20-21, 2018. During the opening of the training section, the Executive Director of LIMPAC, Mr. Del-Francis Wreh thanked the participants for attending the training and asked them to take advantage of the training courses for the benefit of their respective businesses and cooperatives. The training brought together about 125 participants representing more than 45 leaders of women cooperatives, and 40 individual women farmers from thirteen (9) of the fifteen (15) political subdivisions in Liberia.


leadership, communications, and, listening. They were also taught marketing and business plan and how to sustain a business. The trainers who were hired by the ACBF included Madam Betina Edziwa and Madam Grace Kaimila. Each of the participants received a certificate of participation at the end of two days from LIMPAC and ACBF Teams. Speaking on behalf of the women participants, Madam Martha T.W. Sayklon head of Money in the Bush Cooperative of Margibi County thanked the ACBF and LIMPAC for the training and promised that skills acquired were timely and the women will use their new skill to improve their business and the leadership of their respective cooperatives. For her part, Honorable Reginald Sokanteah-Willaims who is the Deputy Registrar General for Administration at the Cooperative Development Agency (CDA) thanked ACBF and BADEA for the support to Liberian women cooperatives and CDA was proud to have participated in the training.

3.0 ATTENDANCE OF WOMEN COOPERATIVES AT THE TRAINING:

Women Cooperatives and individual famers came from nine of the fifteen political subdivisions including Monsterrado County. Each cooperative was represented by two —three members, one person representing the head and the two other serving as administrative staff. Montserrado accounted for the highest number of cooperatives (18 cooperatives) and 19 individual farmers who mainly came from rural Monsterrado County. As indicated in the bar graph, 9 cooperatives came from Bong, followed by 5 from Margibi, and 4 each from Nimba, Bomi, and Lofa counties. Grand Bassa County recorded the second highest number of individual women farmers next to Montserrado County.



4.0 EVALUATION RESULTS OF FORUM AND TRAINING:

At the end of the training participants were asked to provide feedback on the forum and training through simple questionnaires. Ninety seven of the total participants provided responses to questions around various aspects of the forum and training such as: Hotel facility, food quality, training time, transportation arrangement, organization of training, lecture format, group exercises, participant role play, etc.

The below tables show frequencies distributions of some training aspects from the survey questionnaires. From the statistics in the tables below, more than 75-percent of the participants graded the between good and excellent. This signifies strong coordination between ACBF, LIMPAC and CDA.

Tables 4a to 4j show frequency distribution tables for some aspects/activities highlighted in the survey feedback questions. Table 4a demonstrates the frequency of responses on the organization of the training. From this table, 64 respondents said that the organization was excellent. This accounts for about 65.98%; while 25 respondents said it was good which accounts for about 25.77%; whereas, 6 people said it was poorly organized which accounts for about 6.77%; and only 2 people did not respond to this element, which also accounts for about 6.19% respectively. The rest of the tables can be interpreted likewise.

4.2 FEEDBACKS ON TRAINERS

The tables below illustrate respondent's feed back about the training and the trainers. Again as we can see clearly from all the tables, a great number of respondents considered the training activities as well as the resource person(s) performance as being excellent. Interestingly, tables 3 and 5 show that respondents who participated in the survey had no negative feedback about the training elements previously discussed. Similarly, only one respondent out of the 97 stated that the topics were poor presented.



5.0 LOGISTICAL ARRANGEMENTS

The total amount provided by ACBF for the forum and training was US\$28,540. This amount as per the activity agreement was lodged in LIMPAC /ACBF quick win project account at the United Bank for Liberia. Total disbursement on the forum and training amounted to US\$27,600 and were fully accounted for consistent with the activity agreement between the ACBF and LIMPAC.

The expenditure for the forum and training covers, facility rental, food & catering, transportation and accommodation allowances for members of women cooperatives who traveled from the rural Liberia to attend the programs.



In spite of the many challenges, LIMPAC and its team was able to host the women while also successfully hosting the forum and the training sections. Key activities provided by LIMPAC with support from CDA:

- Identification of the Women Cooperatives & Individuals women farmers
- Two way transportation and lodging for all participants at the training.
- Interpretation of services to foreign facilitators
- Carried out evaluation about participants' feedback satisfaction.

6.0 Lessons learnt

Despite the huge success of the forum, there are serious lessons learnt from the organization of the forum and the trainings. These challenges or lessons if not mitigated will cause serious problems to the successfulness of the future programs.

- Participants for the training were oversubscribed because group leaders wanted to benefit from the training in addition to their administrative staff. This aspect put serious constraints on the budget as more cost was incurred for foods and transportation allowances.
- Health insurance cost for the participant was not budgeted. So as some
 of the participants got sick on account long travelling distances or been
 far from home put extra pressure on the budget. There two case of
 hospitalization, which the LIMPAC team carefully handled.
- Some participants had little time to understand resource persons during presentations. This was because presenters' grammar tone was significantly different from the Liberian tone. However, this case was resolved through interpretation services provided by LIMPAC and CDA.

7.0 Recommendations

- 1. Better planning and vetting to avoid over crowdedness.
- 2. Organized more training for women in Agriculture.
- 3. Need to improve lodging facilities and transportation to have all participants assemble on time to the programs.
- 4. Increased the length of the training.
- 5. Proper information dissemination should be done.
- 6. Capacity needs to be expanded/extended to allow many rural women to participate in the training
- 7. Use of more local facilitators and trainers to mitigate the language barrier.
- 8. Rotation of the trainings and other future programs to the rural parts of Liberia, to achieve more ownership of the initiatives.
- 9. Continuous support from the GOL and partners to LIMPAC.
